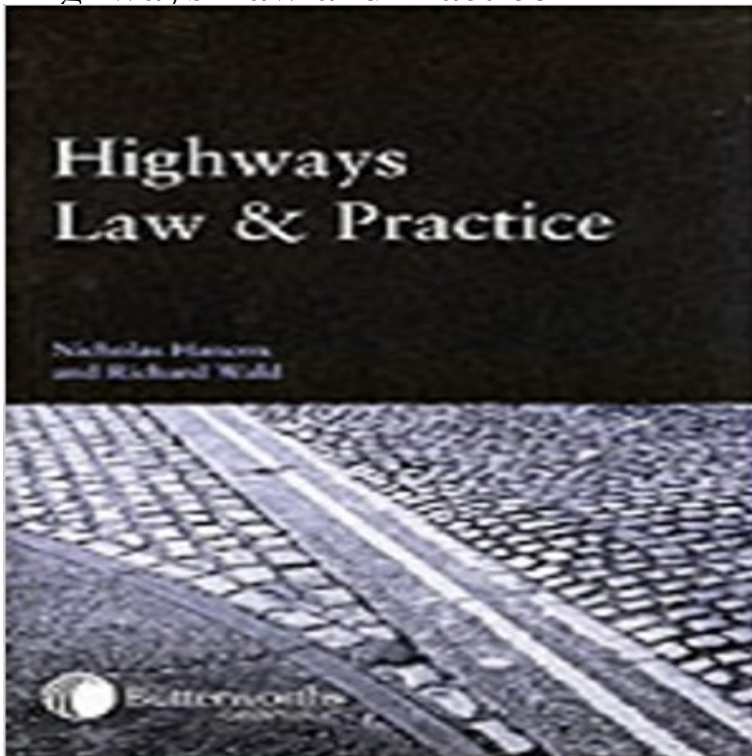


Highways Law and Practice
