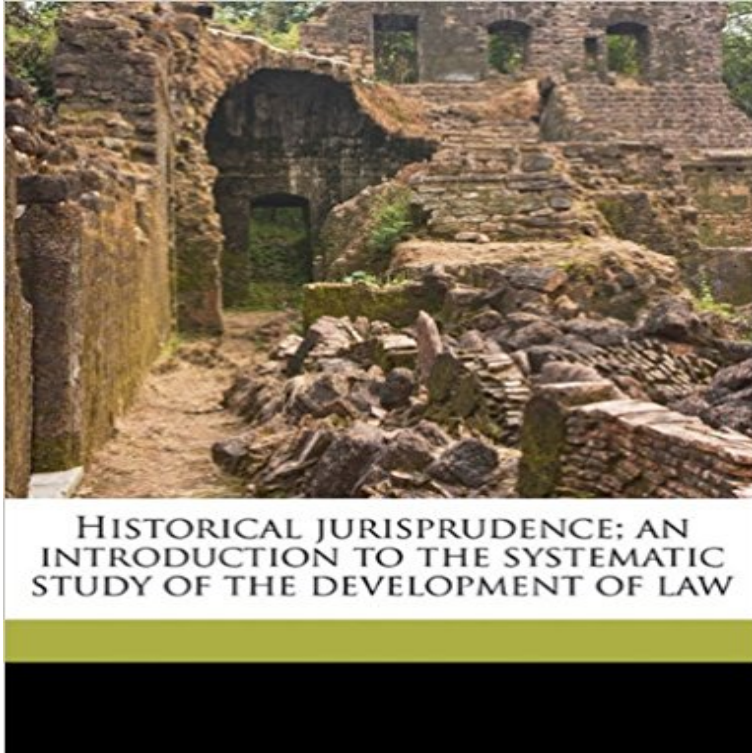


Historical jurisprudence; an introduction to the systematic study of the development of law
