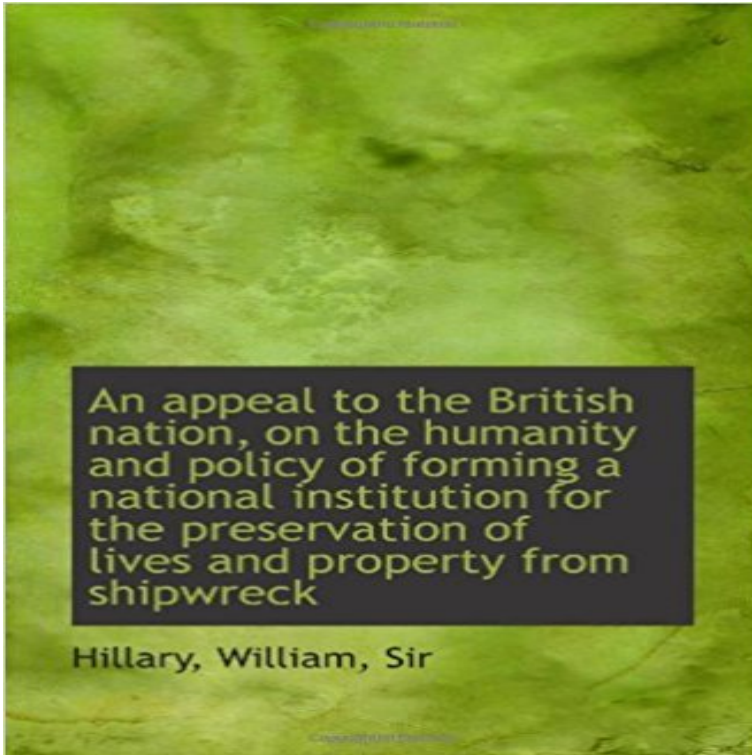


# An appeal to the British nation, on the humanity and policy of forming a national institution for th
