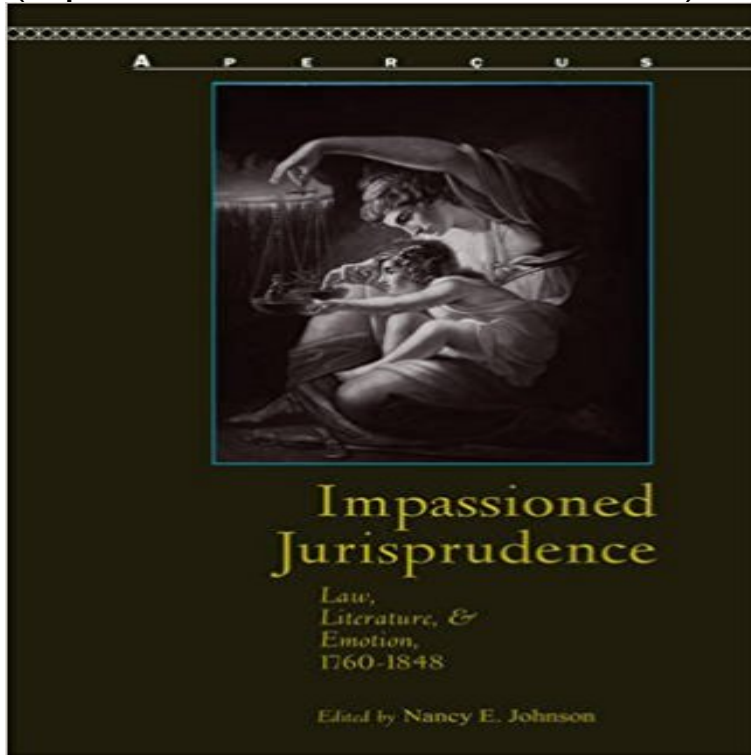


## Impassioned Jurisprudence: Law, Literature, and Emotion, 1760-1848 (Apercus: Histories Texts Cultures)
