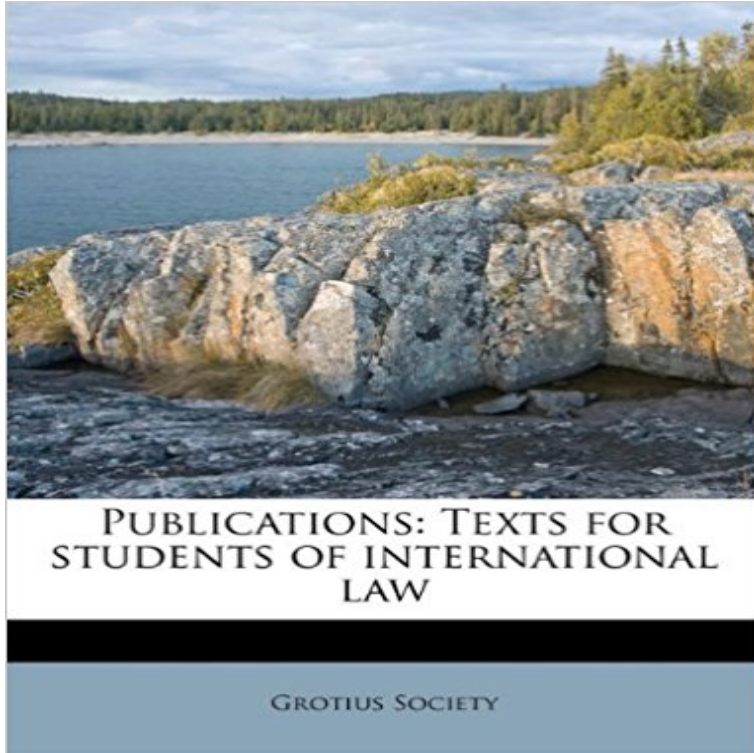


## Publications: Texts for students of international law
