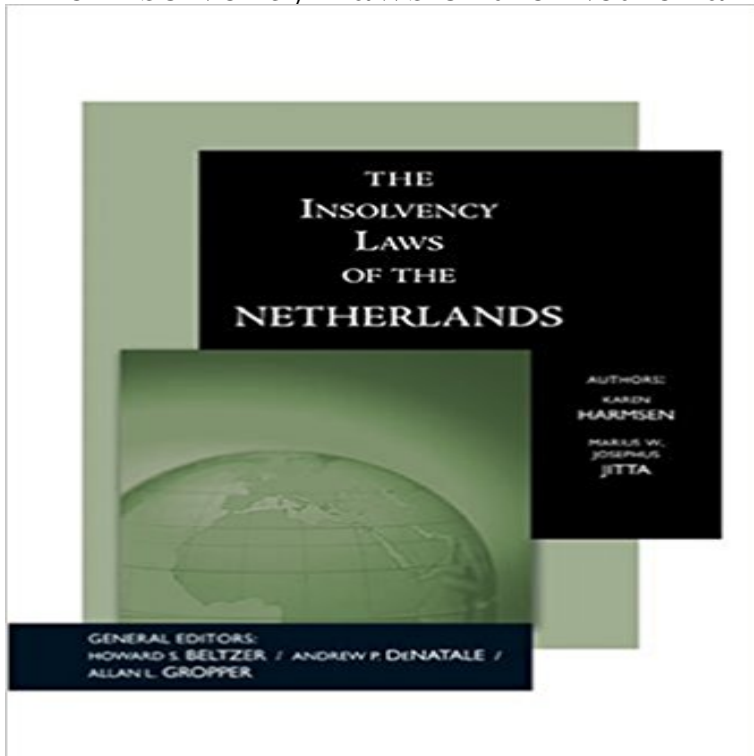


## The Insolvency Laws of the Netherlands

Business failure is as important a part of commercial life as success, and the ability of those who supply credit to protect themselves in the event of insolvency affects not only the cost of credit but a lenders or suppliers willingness to supply it.
