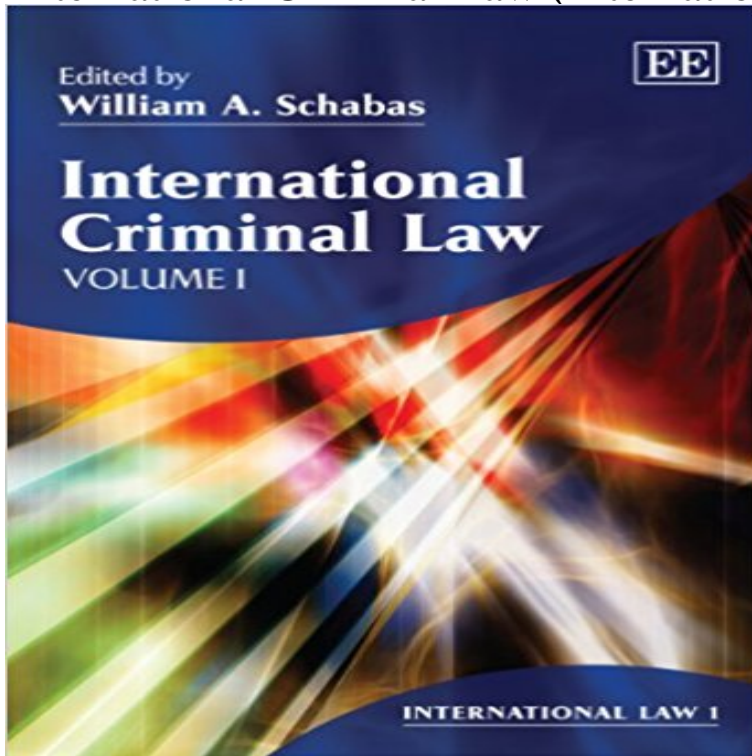


## International Criminal Law (International Law series)
