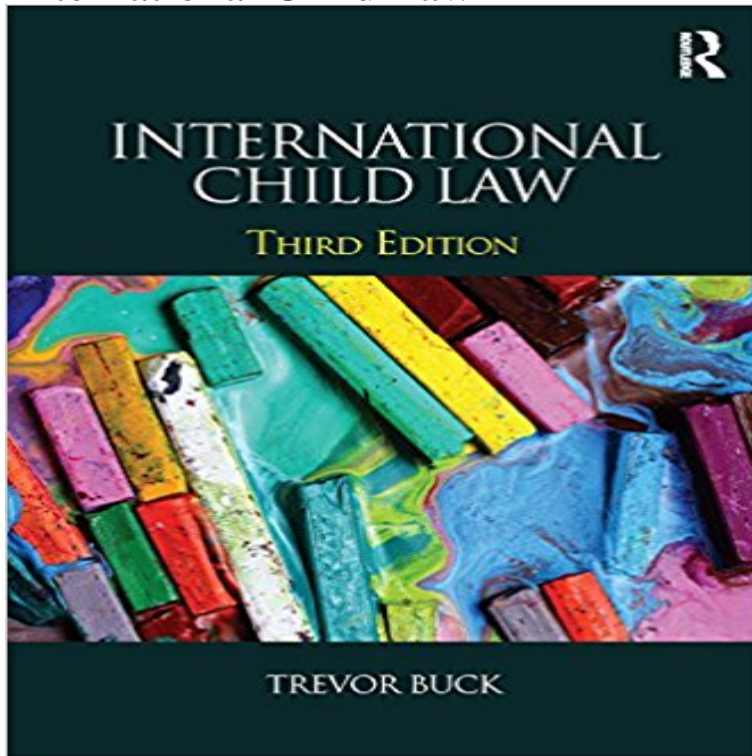


# International Child Law
