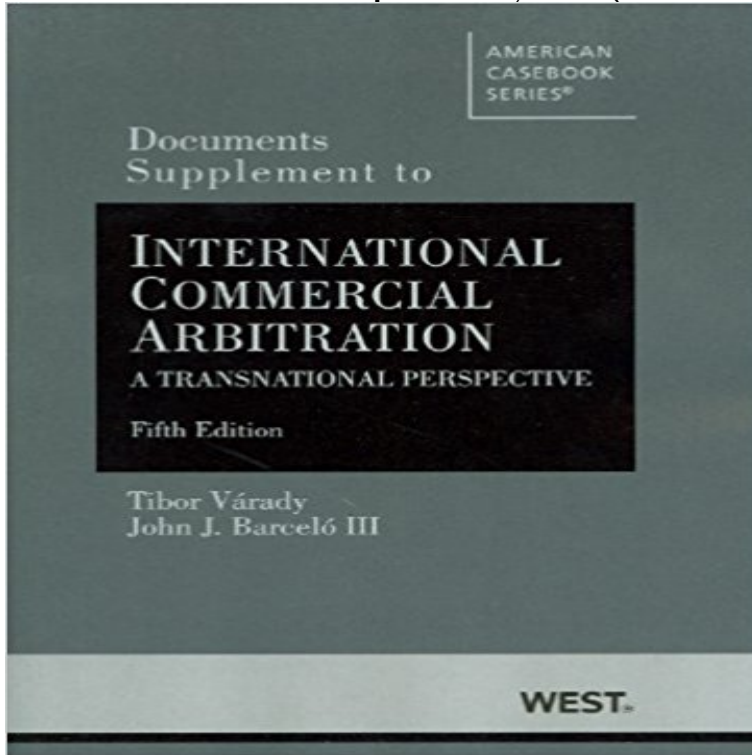


# Documents Supplement to International Commercial Arbitration, A Transnational Perspective, 5th (American Casebook Series)
