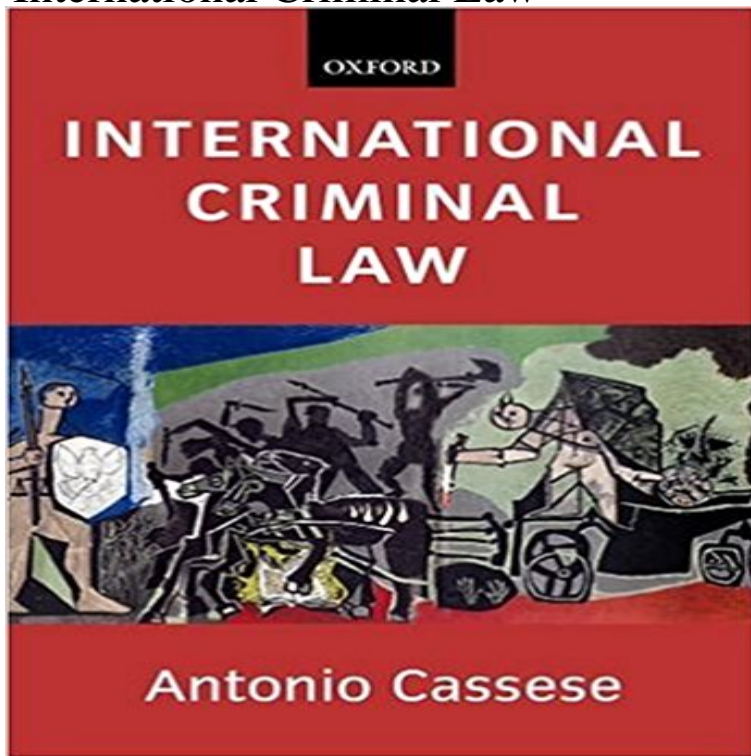


## International Criminal Law
