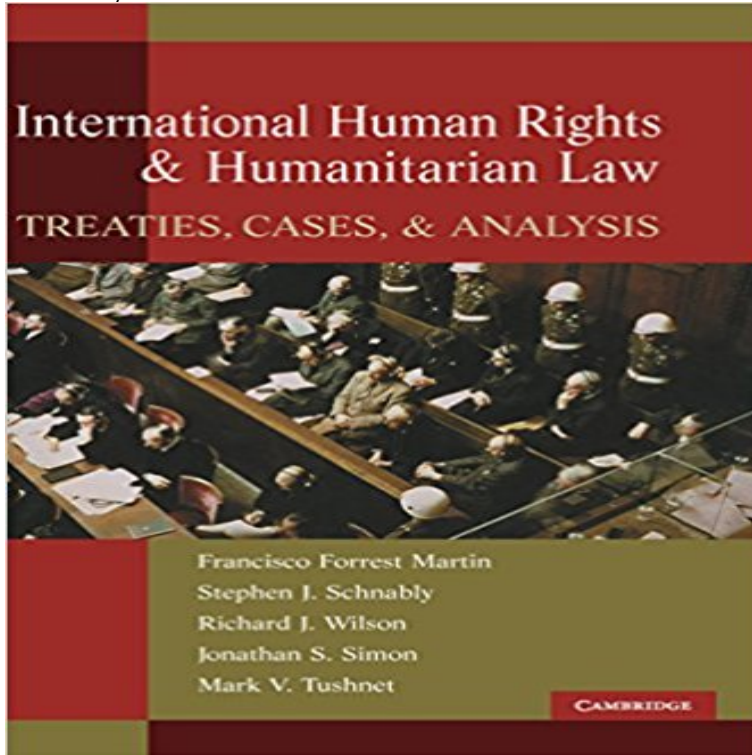


# International Human Rights and Humanitarian Law: Treaties, Cases, and Analysis

Questions and comments sections provide critical analyses of issues raised in the materials. The last chapter addresses theoretical issues facing contemporary international human rights and humanitarian law and its enforcement.
