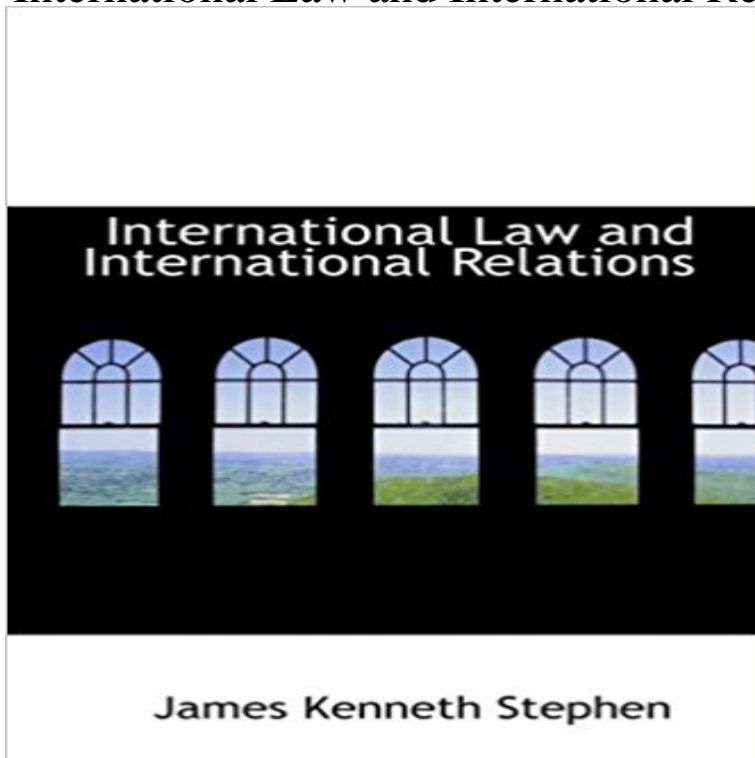


# International Law and International Relations
