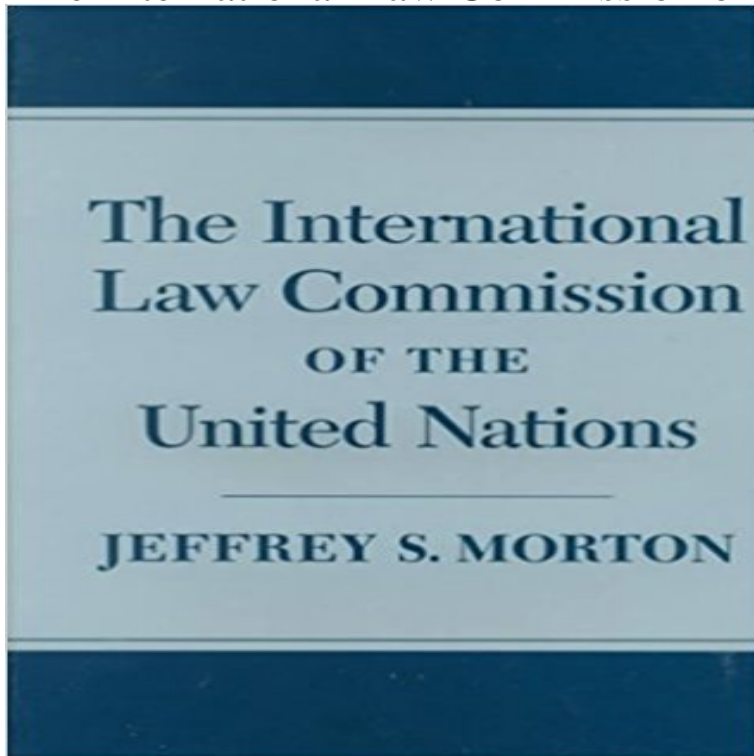


The International Law Commission of the United Nations
