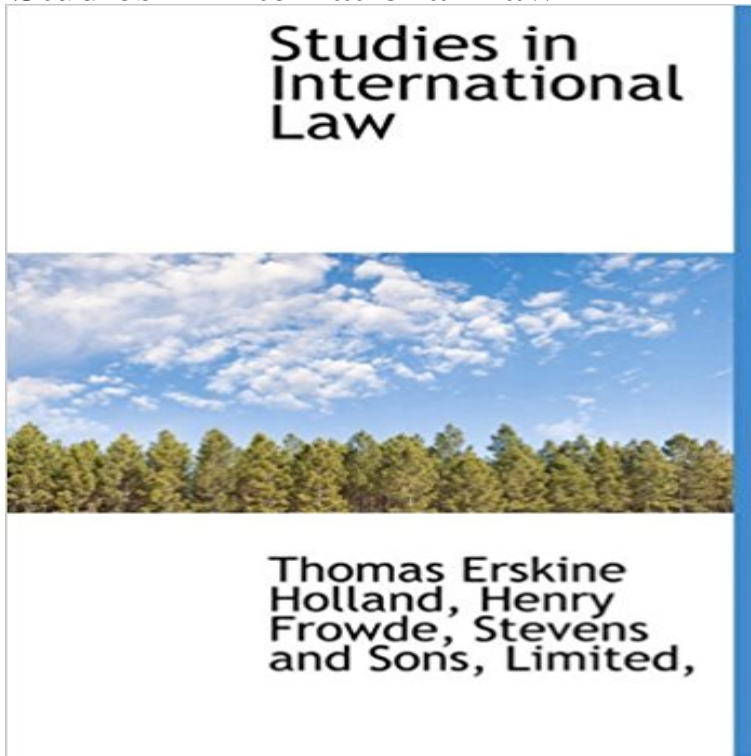


## Studies in International Law
