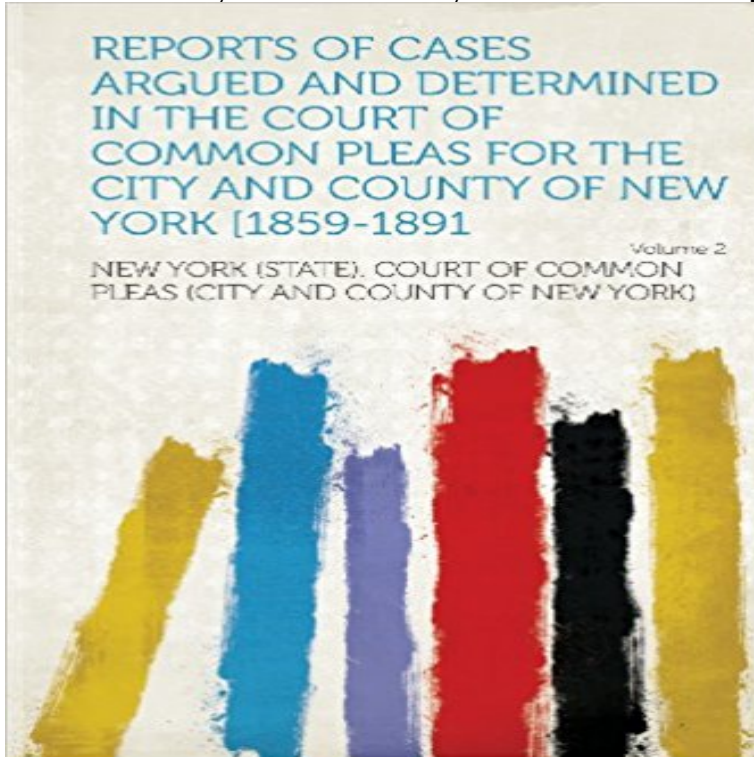


## Reports of Cases Argued and Determined in the Court of Common Pleas for the City and County of New York [1859-1891 Volume 2
