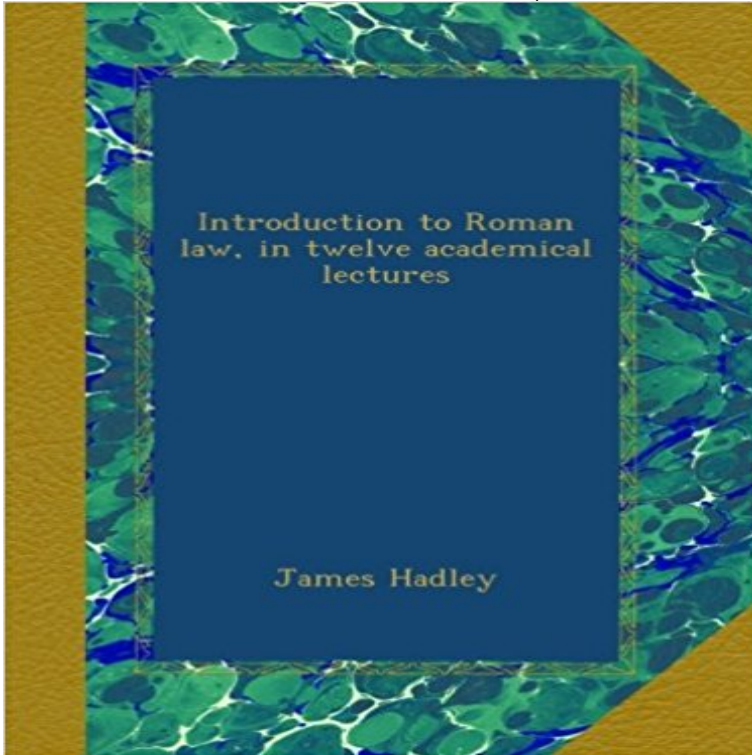


Introduction to Roman law, in twelve academical lectures
