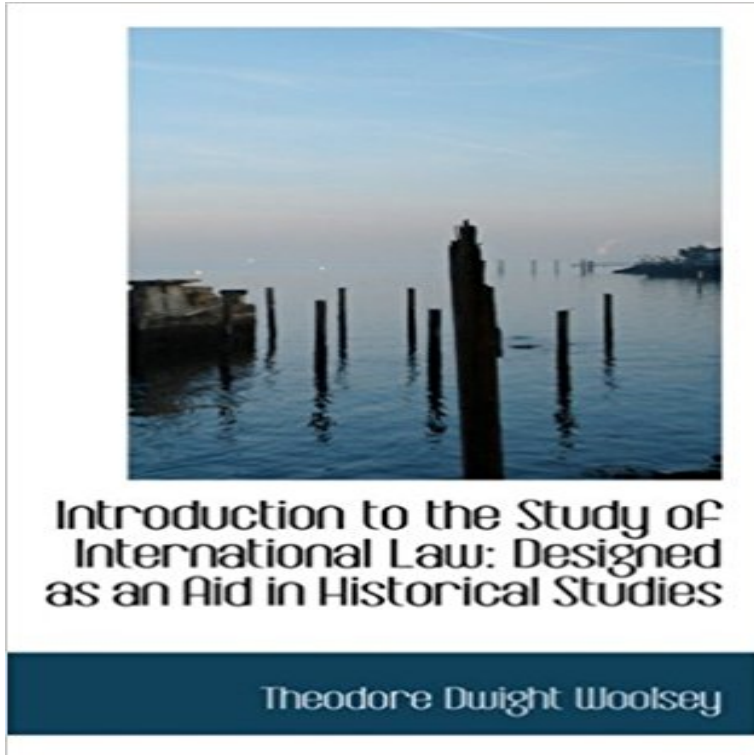


# Introduction to the Study of International Law: Designed as an Aid in Historical Studies
