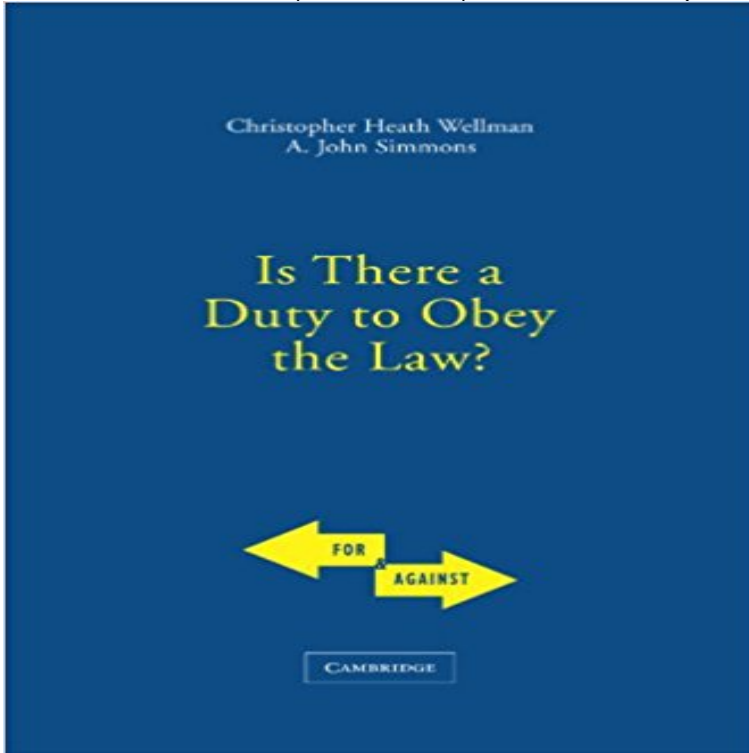


## Is There a Duty to Obey the Law? (For and Against)
