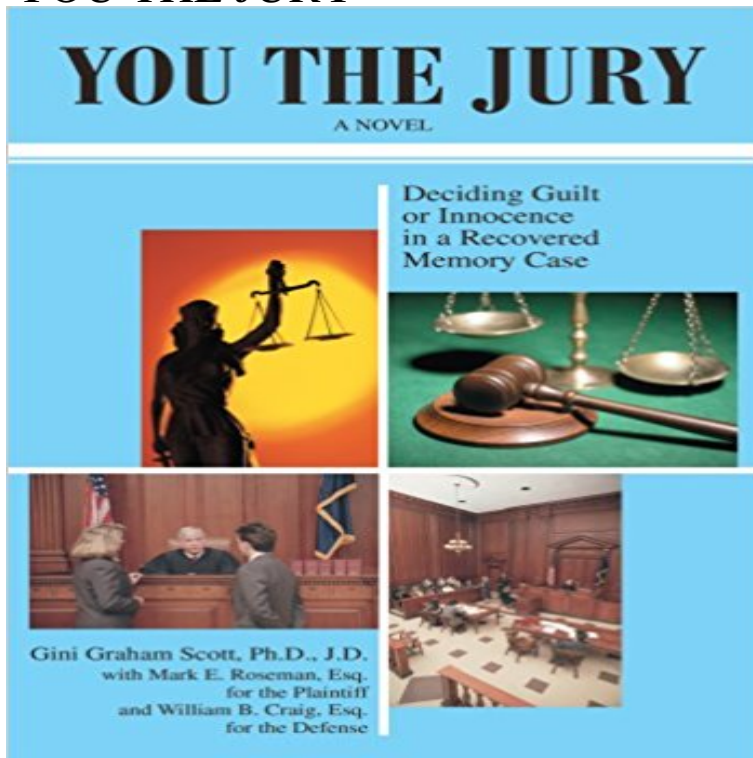


# YOU THE JURY
