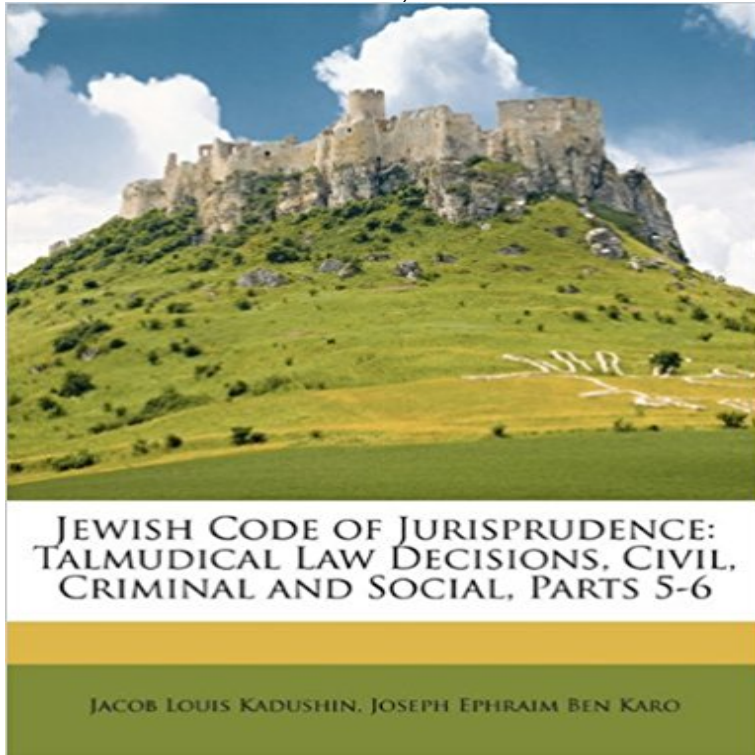


# Jewish Code of Jurisprudence: Talmudical Law Decisions, Civil, Criminal and Social, Parts 5-6
