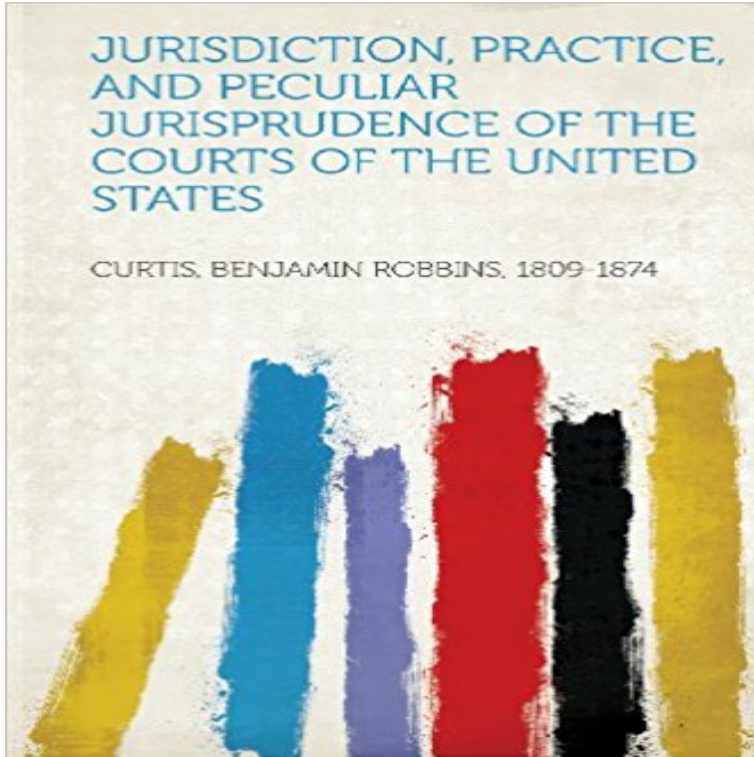


# Jurisdiction, Practice, and Peculiar Jurisprudence of the Courts of the United States
