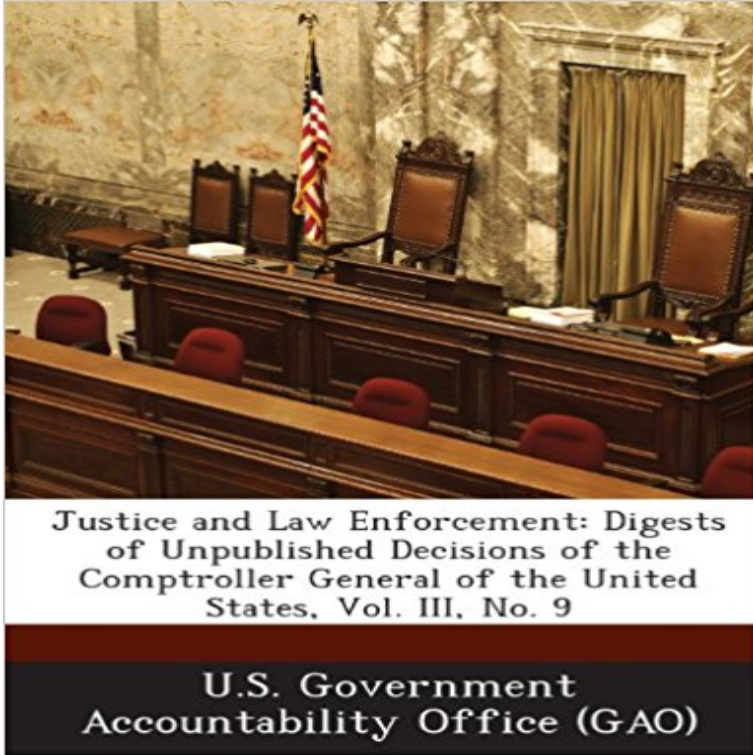


Justice and Law Enforcement: Digests of Unpublished Decisions of the Comptroller General of the United States, Vol. III, No. 9
