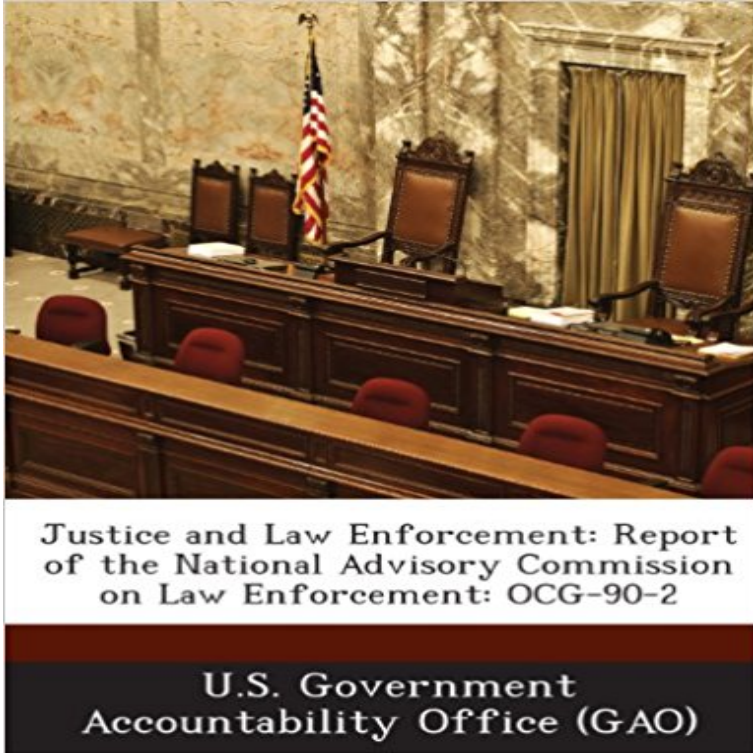


# Justice and Law Enforcement: Report of the National Advisory Commission on Law Enforcement: Ocg-90-2
