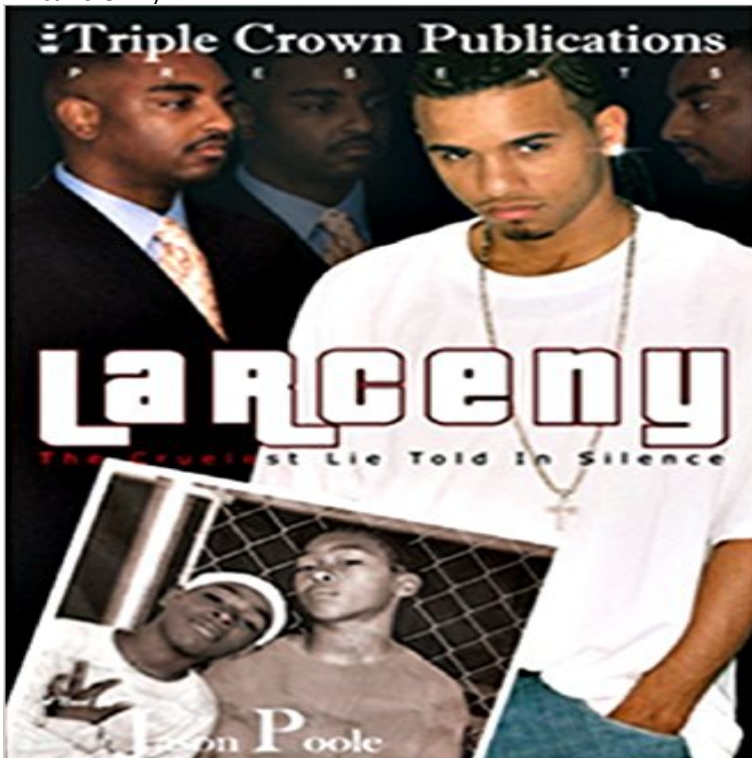


Larceny
