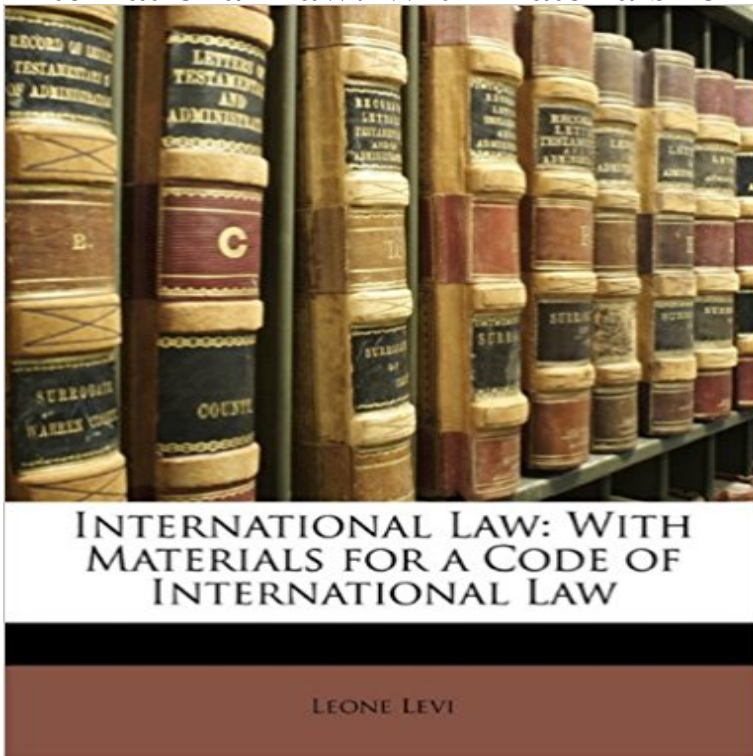


# International Law: With Materials for a Code of International Law
