After graduation, and after a recommendation from then United States associate justice Felix Frankfurter, he worked for the NAACP Legal Defense and Educational Fund. His book *Race, Racism and American Law*, now in its sixth edition, has been a landmark work. Bell and other legal scholars began using the phrase "critical race theory".
