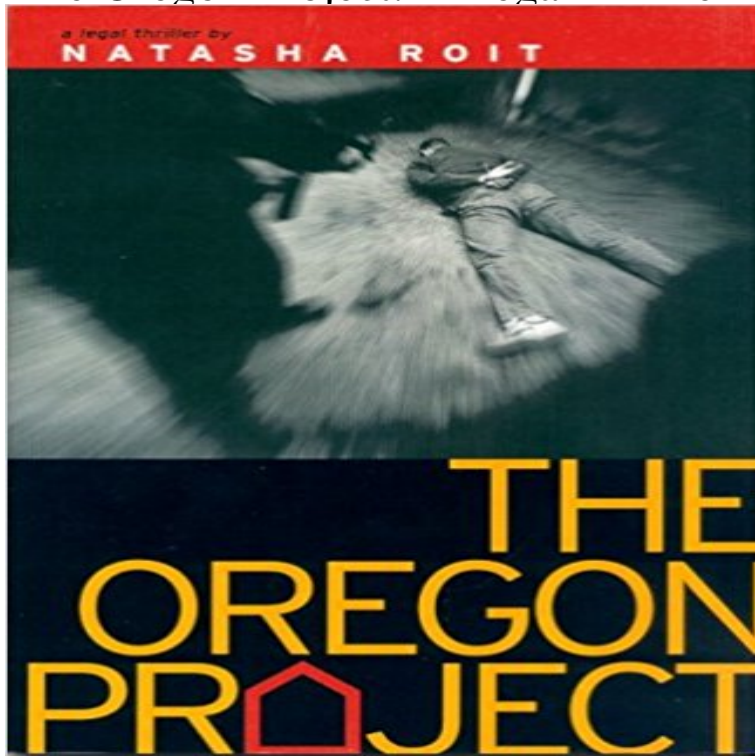


The Oregon Project: A Legal Thriller
