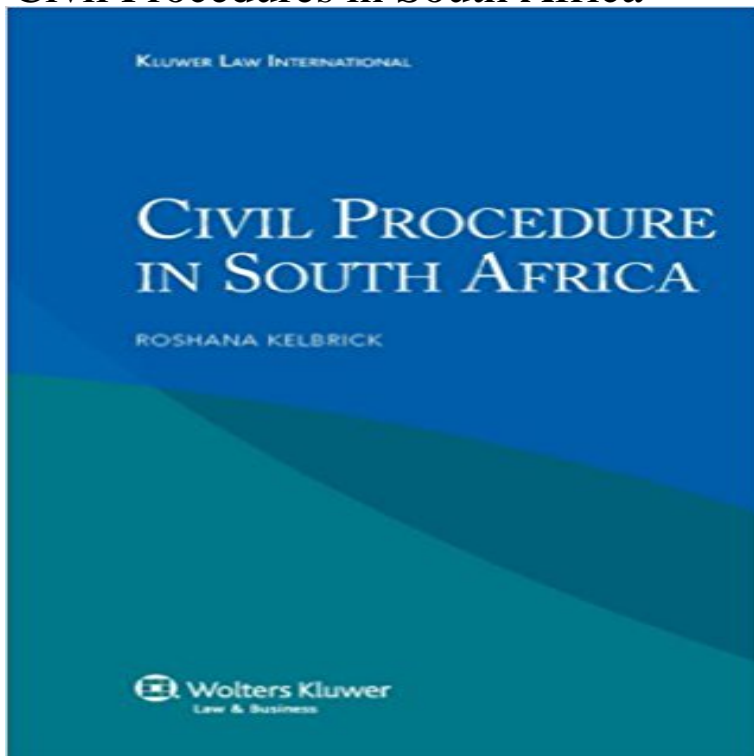


## Civil Procedures in South Africa
