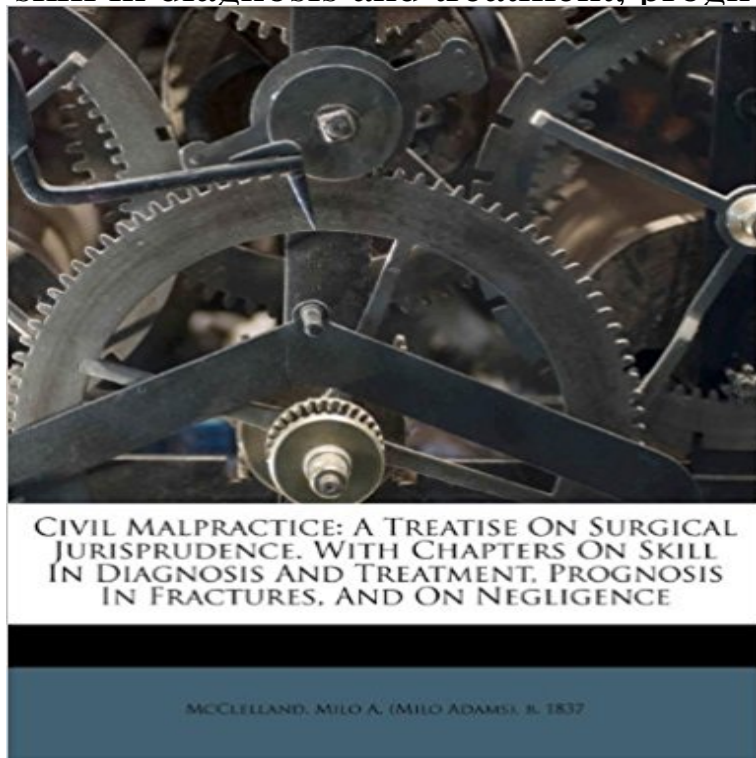


## Civil malpractice: a treatise on surgical jurisprudence. With chapters on skill in diagnosis and treatment, prognosis in fractures, and on negligence
