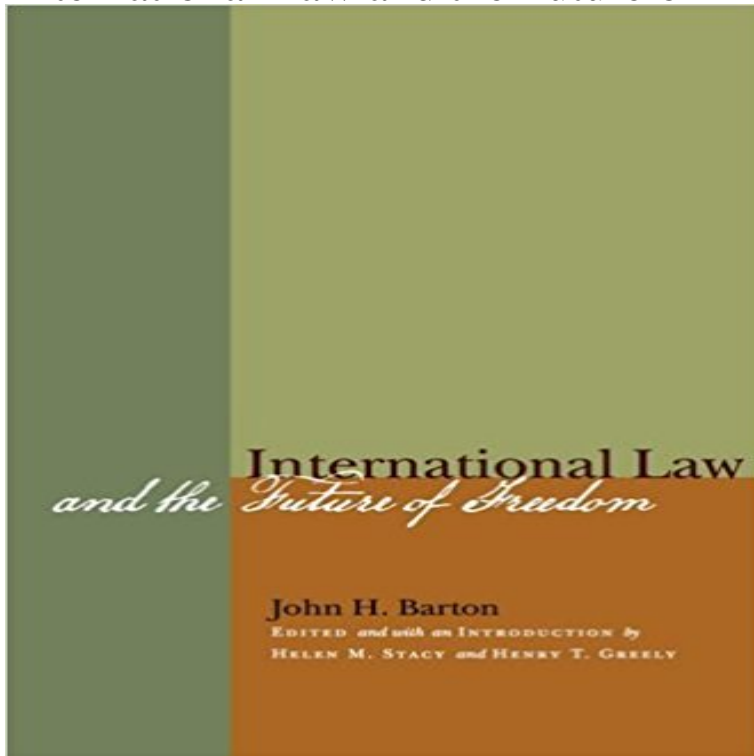


## International Law and the Future of Freedom
