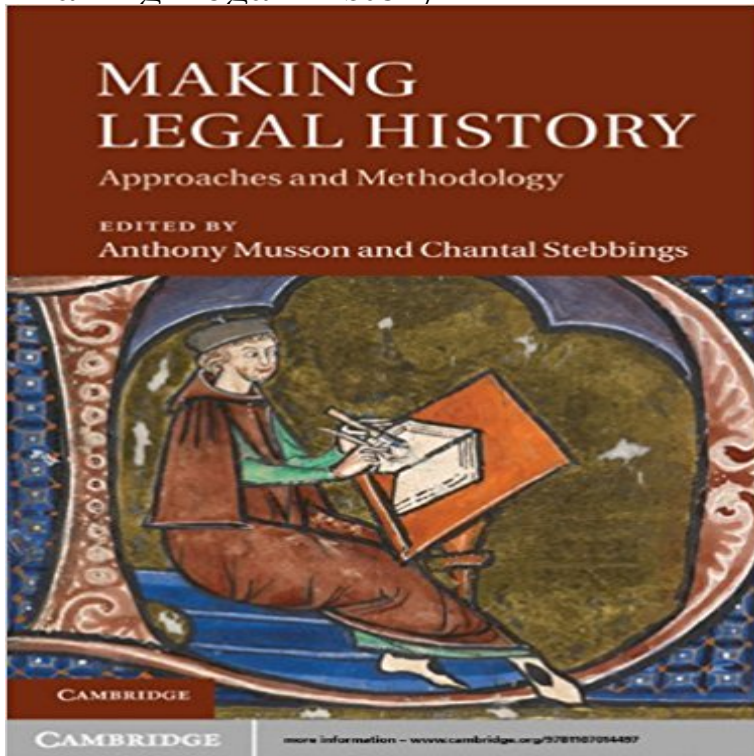


# Making Legal History
