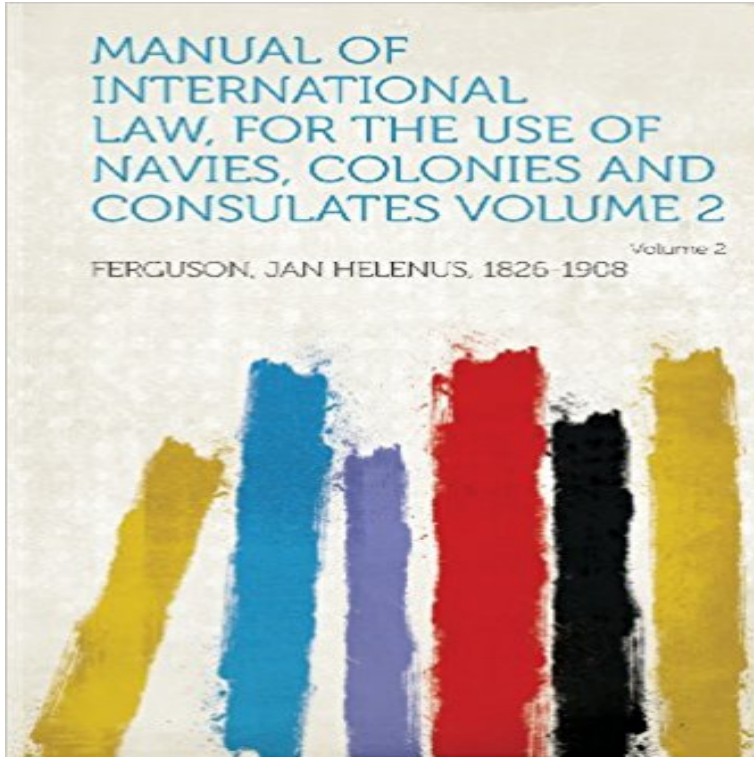


# Manual of International Law, for the Use of Navies, Colonies and Consulates Volume 2
