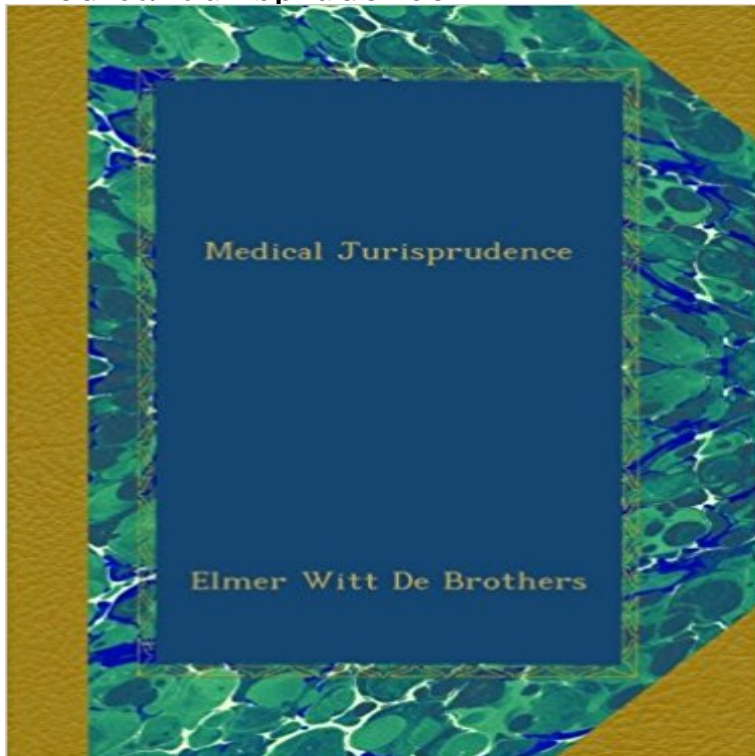


Medical Jurisprudence
