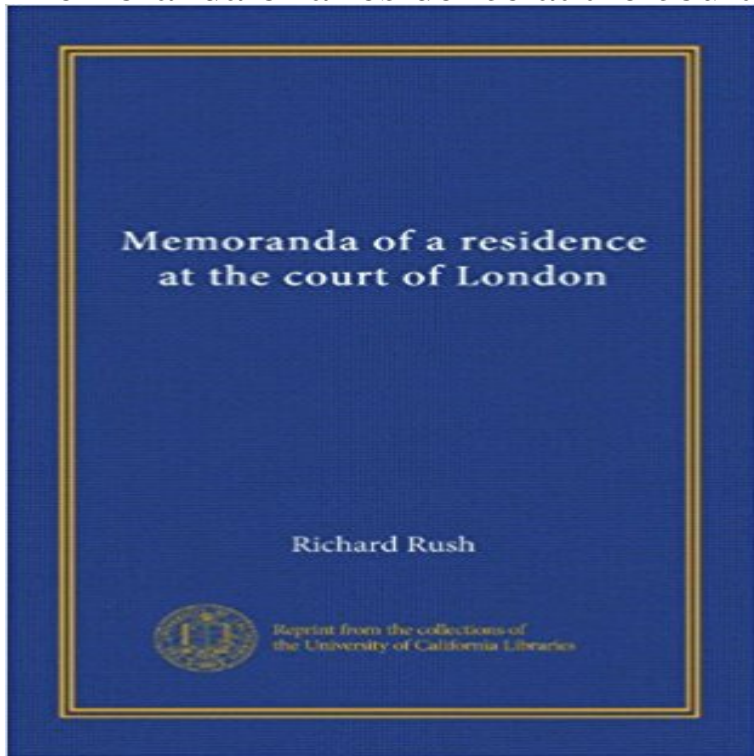


## Memoranda of a residence at the court of London
