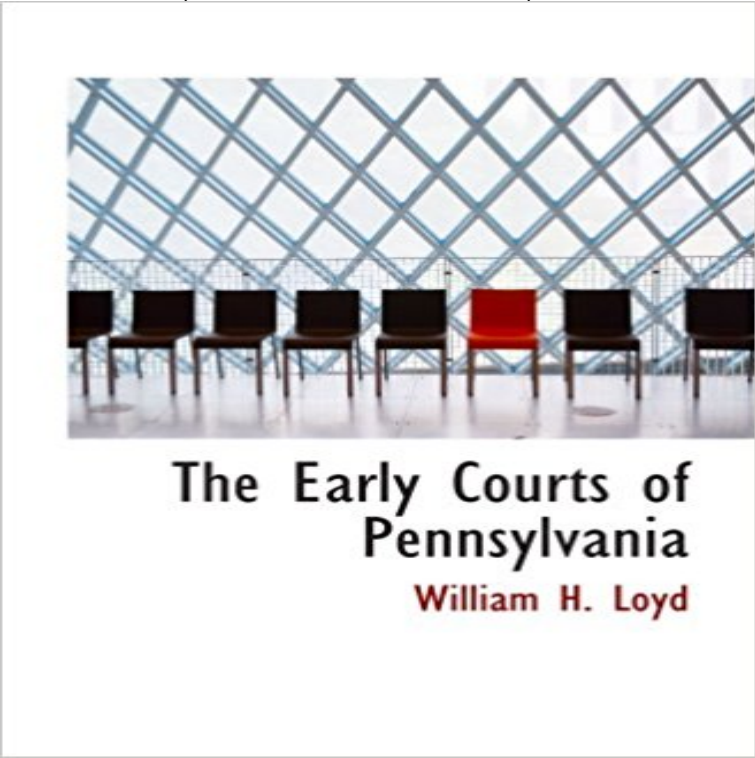


# The Early Courts of Pennsylvania
