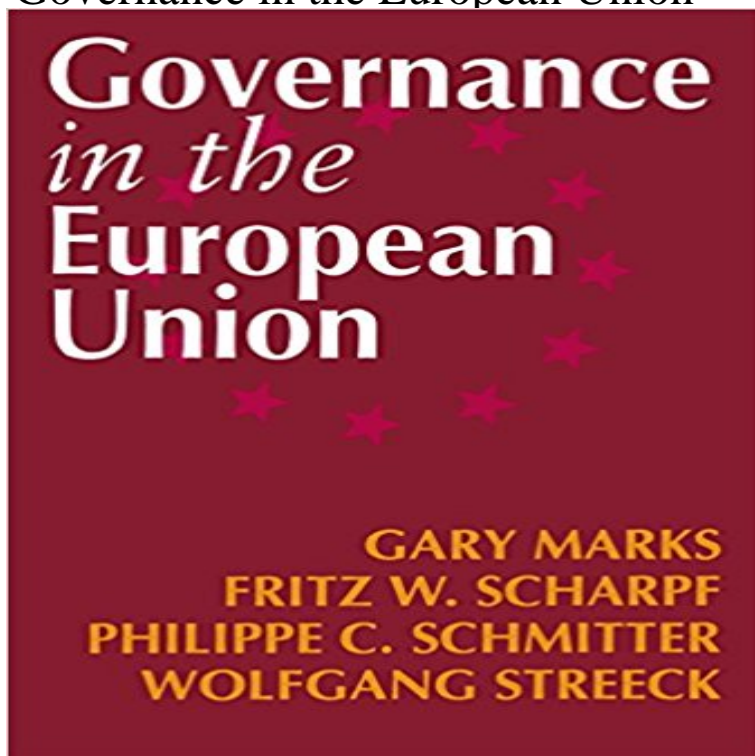


## Governance in the European Union
