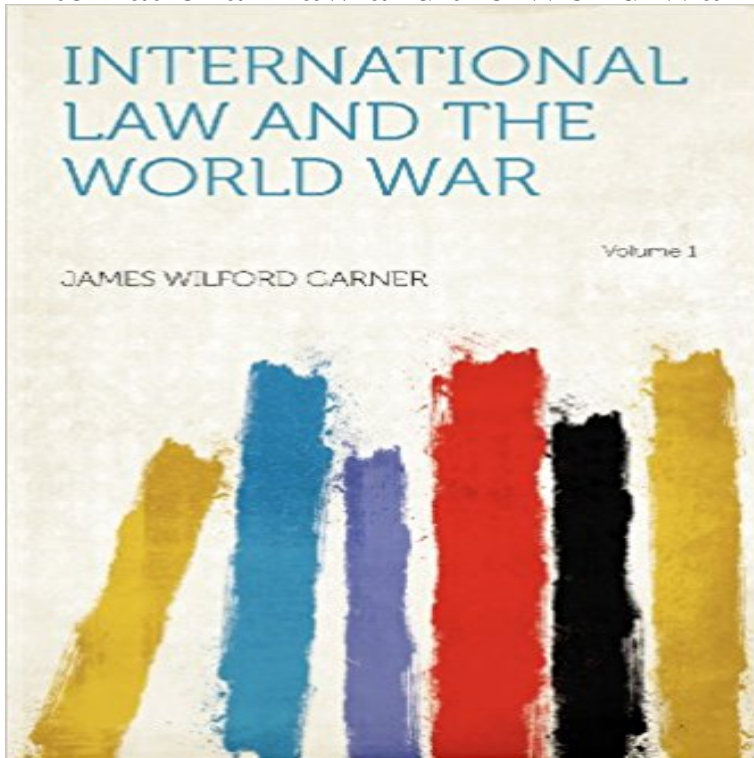


International Law and the World War Volume 1
