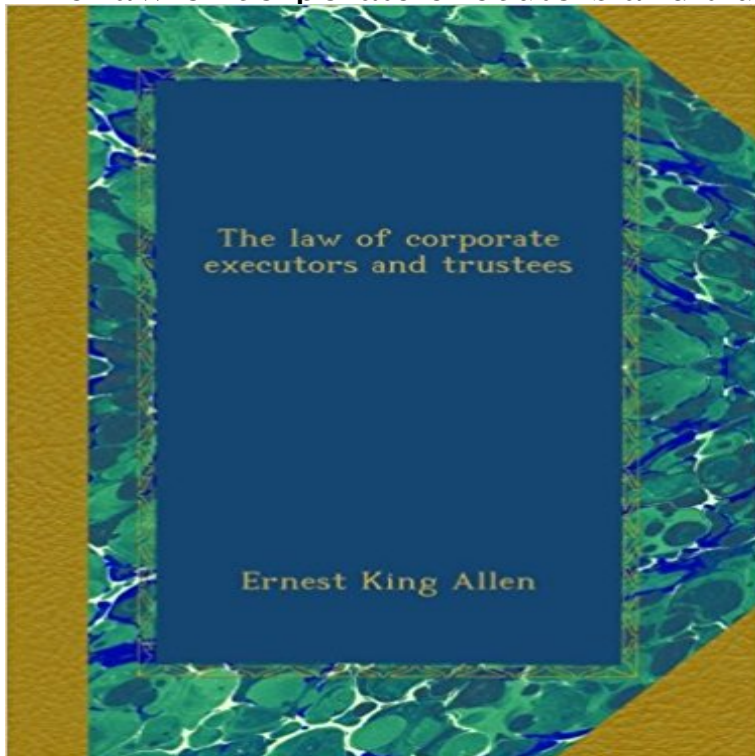


The law of corporate executors and trustees
