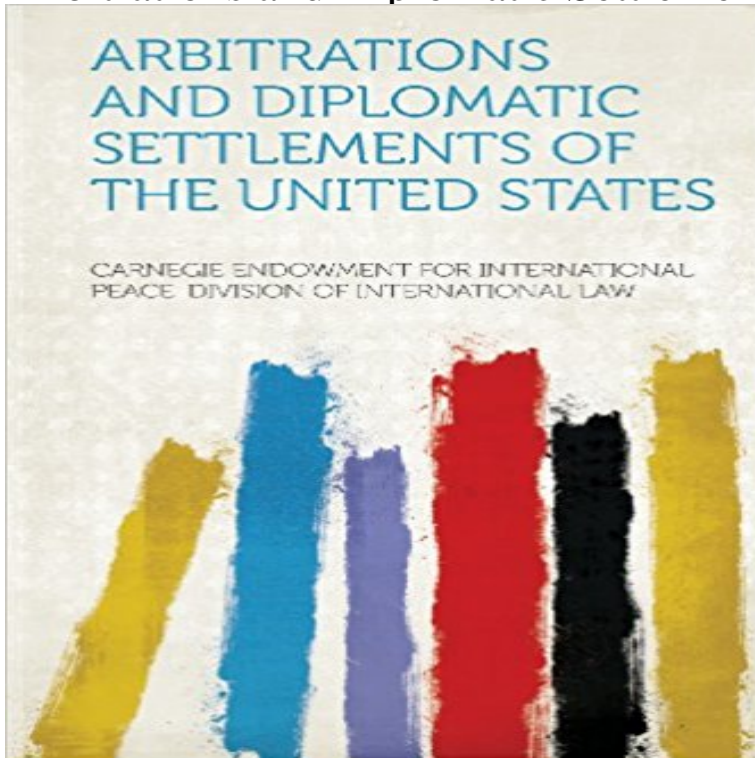


Arbitrations and Diplomatic Settlements of the United States
