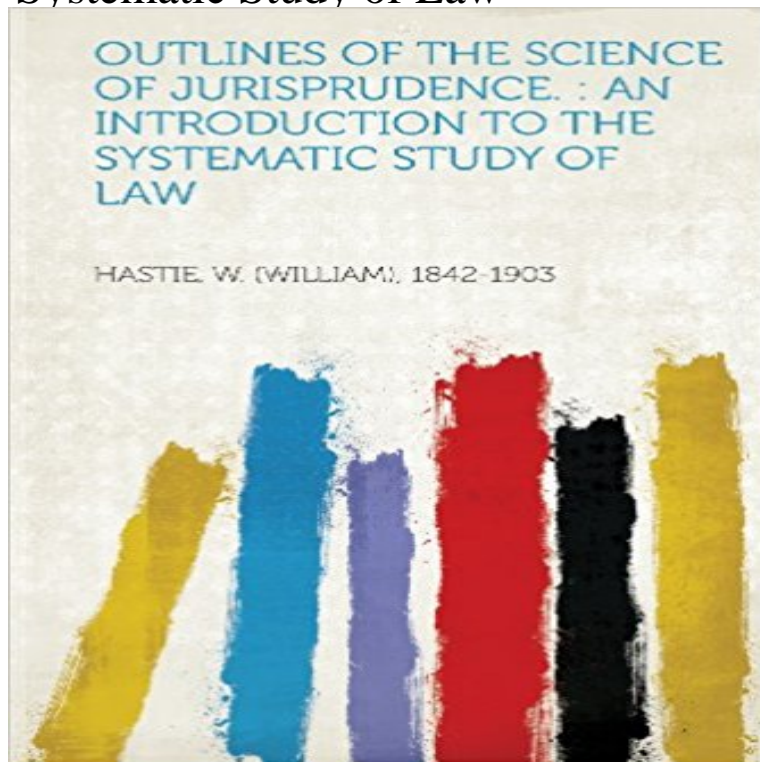


Outlines of the Science of Jurisprudence.: An Introduction to the Systematic Study of Law
