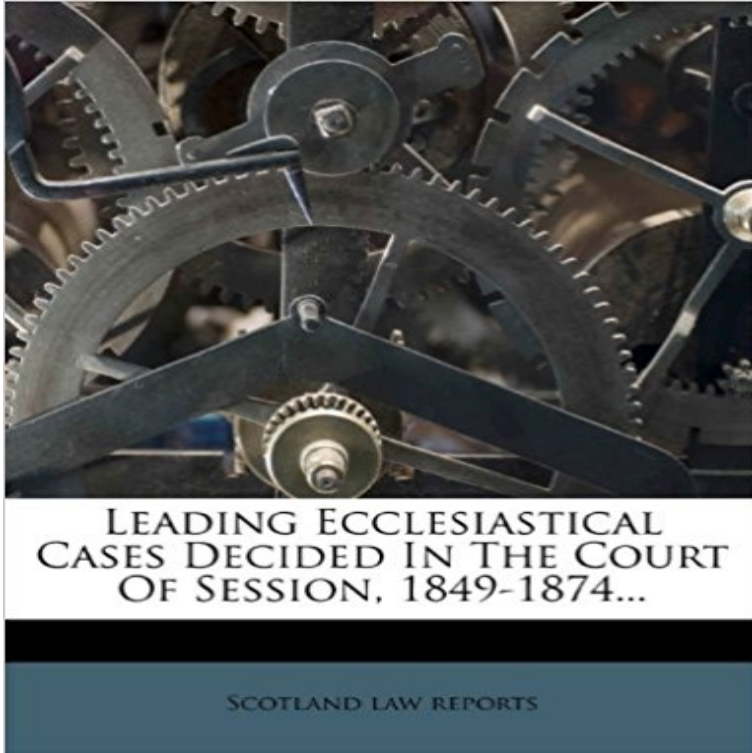


# Leading Ecclesiastical Cases Decided in the Court of Session, 1849-1874...
