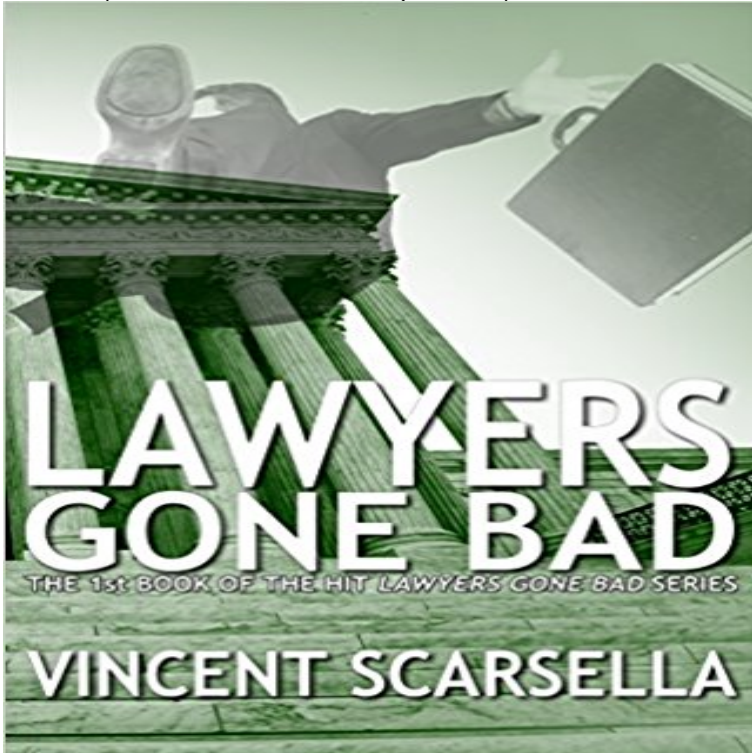


## Lawyers Gone Bad (Lawyers Gone Bad Series Book 1)
