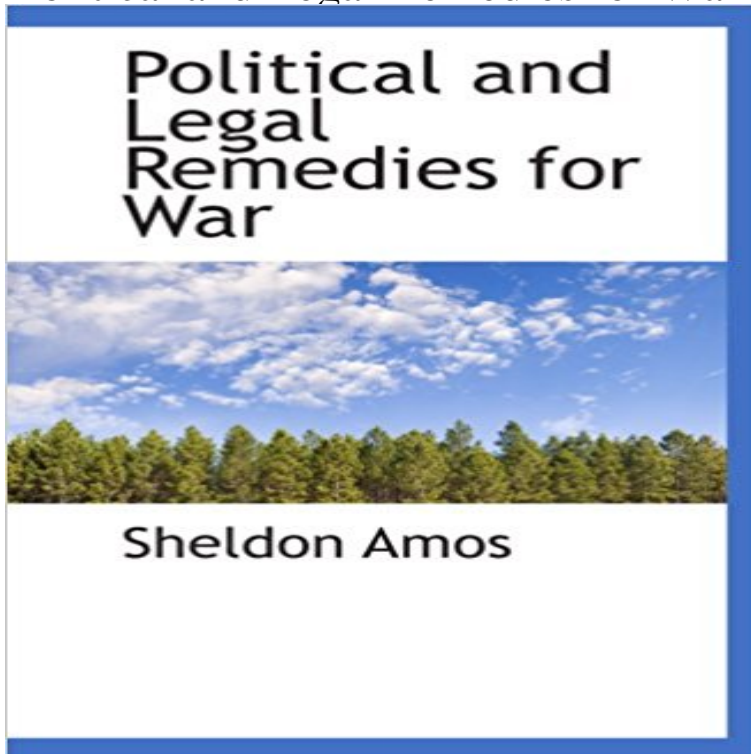


Political and Legal Remedies for War
