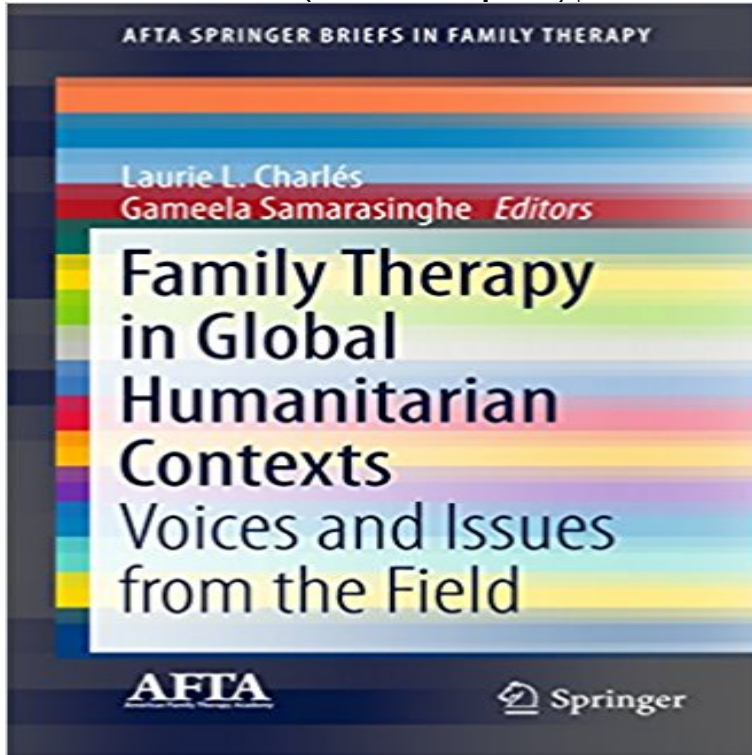


# Family Therapy in Global Humanitarian Contexts: Voices and Issues from the Field (AFTA SpringerBriefs in Family Therapy)
