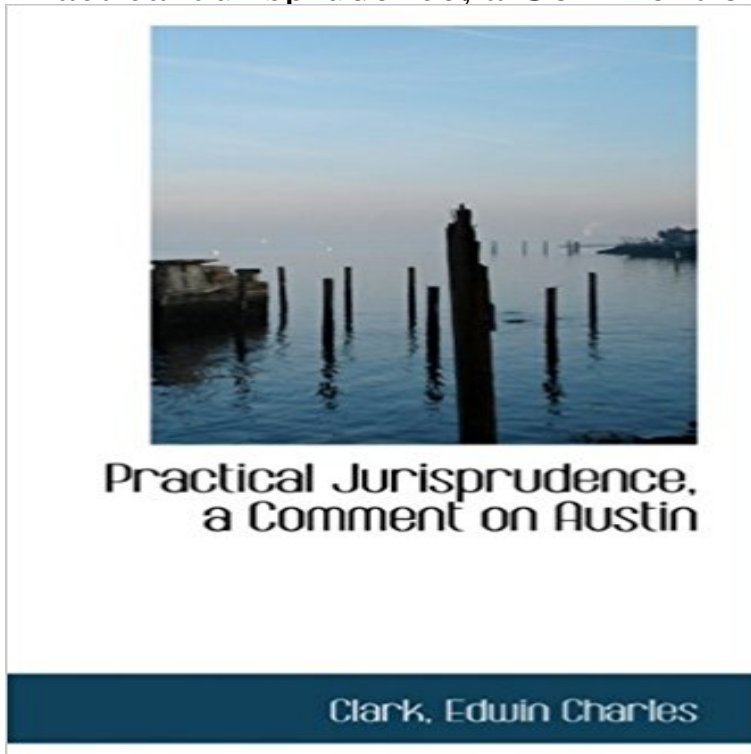


## Practical Jurisprudence, a Comment on Austin
