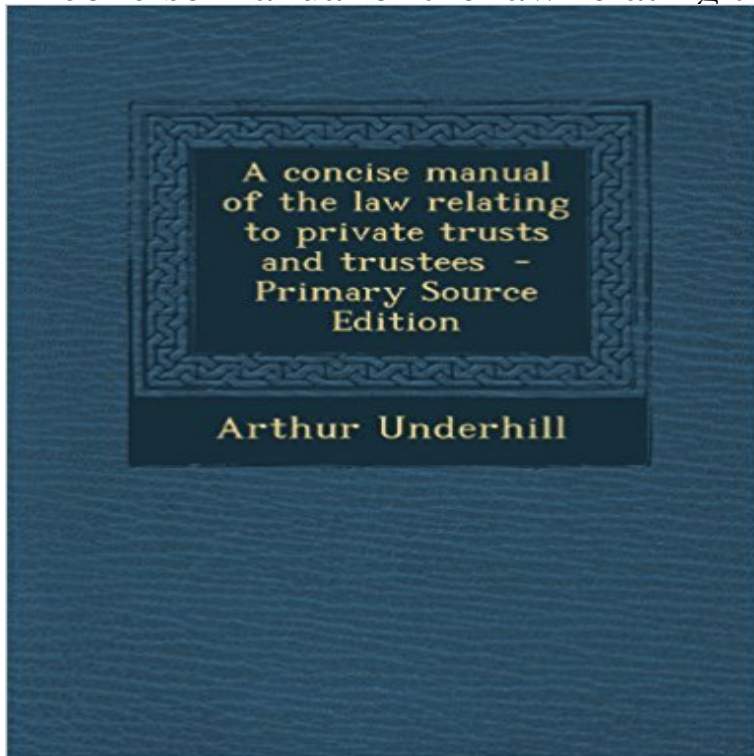


## A concise manual of the law relating to private trusts and trustees
