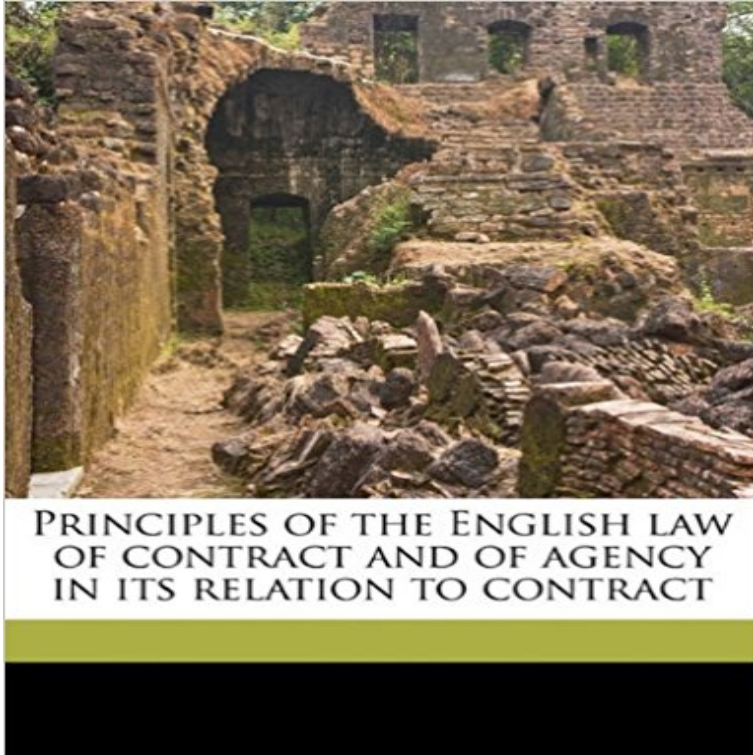


# Principles of the English law of contract and of agency in its relation to contract
