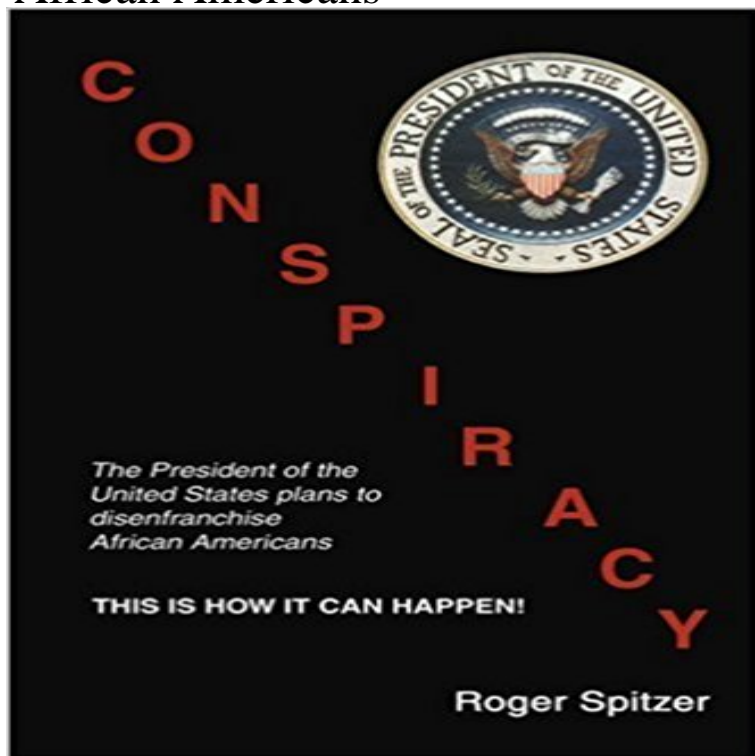


## Conspiracy: The President of the United States plans to disenfranchise African Americans
