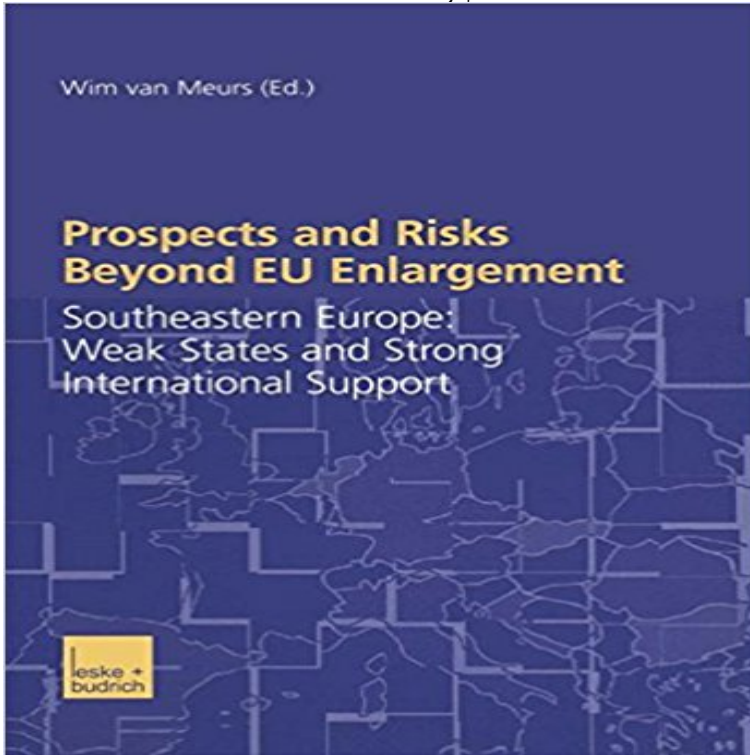


# Prospects and Risks Beyond EU Enlargement: Southeastern Europe: Weak States and Strong International Support

The authors explore the unintended consequences and side-effects of massive support for reforms and external influence on weak states. A concept for a Multi-Layered Europe is developed for the strategic dilemmas concerning the current debate on Wilder Europe.
