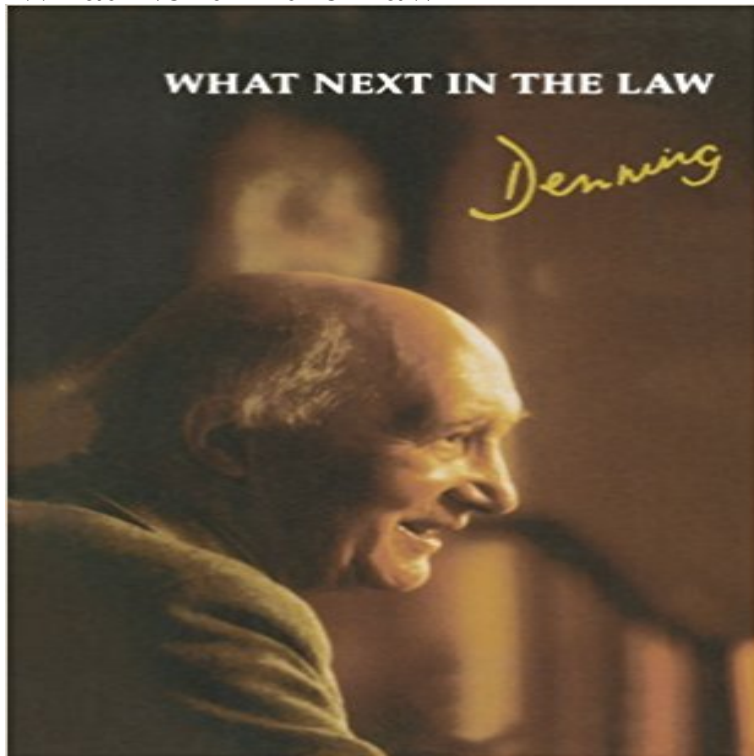


## What Next in the Law
